



At South-End Tech Limited, our team of professionals deliver the training using a blend of the following methods:

It takes into account any style of training, both informal and formal, to determine aptitude based on four levels: Reaction level that measures how participants react to the training (e.g. satisfaction); Learning level to analyses if participants truly understood the training (e.g. increase in knowledge, skills, or experience); Behavior level to looks if participants are utilising what they learned at work (e.g. change in behaviors); and Results level to determine if the material had a positive impact on the business/organization

To test the effectiveness of the training using this training methodology, participants will be issued a pre-assessment before the training and a post-assessment upon completion. Post-training assessments and evaluations will be conducted to measure the effectiveness of the training. Our KEPT provides customized handouts and reference

materials to the participants. Participants also have access to industry-recognized online learning portals as well as websites, which offer a variety of cybersecurity courses, practical labs, and certification tracks. These platforms provide flexible learning options, including video tutorials, interactive exercises, and hands-on virtual environments, allowing participants to learn at their own pace and deepen their expertise in real-world scenarios. Further, our KEPT facilitators use real-world case studies and tools for practical learning.
